**Summary Annual Report for**  
**THE AEROSPACE RETIREE MEDICAL PLAN**

This is a summary of the annual report for The Aerospace Retiree Medical Plan, EIN 95-2102389, Plan Number 503, for the period October 1, 2021 to September 30, 2022. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has (a) contract(s) with Blue Cross of California, BLUE CROSS OF CALIFORNIA (HMO CA), Kaiser Permanente Mid-Atlantic, Northern California Kaiser Foundation Health Plan, Kaiser Foundation Health Plan, MONUMENTAL LIFE INSURANCE COMPANY (TRICARE), and BLUECROSS BLUESHIELD OF NEW MEXICO to pay the following types of claims incurred under the terms of the plan:

The total premiums paid for the plan year ending September 30, 2022 were \$10,873,075.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$170,806,095 as of September 30, 2022, compared to \$213,088,998 as of October 1, 2021. During the plan year the plan experienced a change in its net assets of \$-42,282,903. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$-29,547,521 which included employer contributions of \$0, employee contributions of \$6,273,167, other contributions of \$0, gain/loss of \$0 from the sale of assets, and earnings from investments of \$-35,820,688.

Total plan expenses were \$12,735,382. These expenses included \$44,873 in administrative expenses and \$12,690,509 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
